CONSENT TO SFM OBTAINING AND USING PERSONAL CREDIT INFORMATION

This document gives SFM authority to seek, use and disclose certain information about you in connection with commercial credit, which may be extended to the Applicant overleaf.

Please read this document carefully. If you do not understand this document you should seek appropriate advice before signing overleaf

1. I acknowledge that Sydney Fish Market Pty Ltd (ACN 064 254 306) ("SFM") may, and I authorise SFM to
 - (a) obtain a credit report (as defined in the Privacy Act 1988 (Cth)) containing information about me for the purpose of assessing an application for commercial credit made by the Applicant to SFM and/or assessing whether to accept me as a guarantor for commercial credit applied for by the Applicant;
 - (b) obtain a credit report containing information about me for the purpose of collecting overdue payments from the Applicant in respect of the commercial credit referred to above, or from me under any guarantee provided by me referred to above;
 - (c) provide a credit reporting agency with personal information about me for the purpose of obtaining the credit reports referred to above;
 - (d) exchange information about me with any credit provider named in this application or named in a credit report for the purposes of deciding whether to accept me as a guarantor for commercial credit applied for by the Applicant, to notify of a default by me under that guarantee and to exchange information with other credit providers about the status of any such guarantee;
 - (e) review the credit worthiness of the Applicant from time to time, with a view to determining whether SFM requires further security from the Applicant in respect of the commercial credit facility, andobtain credit reports and exchange information with credit providers as set out above in respect of such a review as though it were a fresh application for commercial credit.

 - (b) commission a third party to prepare a report for SFM in relation to my or the Applicant's credit worthiness;
 - (c) disclose to any person (including any third party) any financial information concerning me and any guarantee provided by me in respect of the commercial credit applied for by the Applicant.
