TERMS & CONDITIONS FOR FILMING AT SYDNEY FISH MARKET

(Please read carefully and sign in agreement)

The above-mentioned party understands and agrees to:

1. Comply with Sydney Fish Market Pty Ltd's terms, conditions and regulations.
2. Provide Certificates of Currency for all insurance policies, including \$20,000,000 of Public Liability Insurance.
3. Ensure the health and safety of those involved in the production at all times.
4. Pay location fees to Sydney Fish Market Pty Ltd as determined by prior arrangement. (At the discretion of Sydney Fish Market Pty Ltd, location fees may be waived in return for recognition of Sydney Fish Market as well as logo inclusion).
5. If location fees have been waived, Sydney Fish Market must be credited. Please ensure that all verbal or written credits are to Sydney Fish Market (there is no 's' at the end of our company name).
6. Cover costs pertaining to the purchase of any seafood or product required to complete the shoot.
7. If it is a shoot where payment for services is involved, pay a cancellation fee in the event of filming being cancelled. If the party cancels within twenty-four hours of the shoot, cancellation fees are 50% of location fee plus any additional expenses already incurred. Filming can be rescheduled as a result of poor weather, including costs of expenses to date.
8. Comply with WH&S regulation to wear coloured vests (supplied by Sydney Fish Market Pty Ltd) and closed toed shoes at all times on the auction floor, loading dock and all restricted areas (this includes all persons appearing on camera). Failure to return vests to Sydney Fish Market Pty Ltd will incur a cost of \$40.00 per vest.
9. Please note: parking may be limited to a certain number of vehicles. Due to the nature of the site, parking spots cannot be reserved, with the exception of large trucks.
10. Sydney Fish Market Pty Ltd reserves the right to view/approve content prior to airing. This will only occur if Sydney Fish Market Pty Ltd foresees that any footage will be damaging or defamatory.
11. The footage/photography must not be used for any other purpose, other than the project outlined in this application. Project refers to footage for episodes as well as any advertising, marketing or promotion for the show.
12. Unless otherwise agreed to, footage or photographs taken at Sydney Fish Market may not be on-sold to a third party or sold as stock footage.
13. It is the responsibility of the photographer and/or videographer to obtain the relevant model releases for people captured on film.
14. You give Sydney Fish Market Pty Ltd permission to take photographs for internal and publicity use. This use may include, but is not limited to: Sydney Fish Market Pty Ltd's social media sites and Sydney Fish Market retailer's social media sites. Please notify Sydney Fish Market Pty Ltd BEFORE filming/photographing if there are any restrictions e.g. only able to publish pictures after the episode airs.
