CERTIFICATE

The following conditions apply to the Registered Fish Receiver:

Sydney Fish Market Pty Ltd

1. The person or company must register the premises where fish will be received from commercial fishers or persons acting on behalf of commercial fishers. These premises will be identified on the Certificate of Registration.
2. All fish received from commercial fishers or persons acting on behalf of commercial fishers must physically pass through the premises identified on the Certificate of Registration unless an exemption to this requirement has been granted by New South Wales Department of Primary Industries (NSW DPI).
3. Any changes to the information supplied to NSW DPI on the Receiver Application Form after initial certification must be notified to the Fish Receiver Registrar, NSW DPI, in writing prior to the changes taking place (changes of Directors, Locations etc).
4. All fish received for resale or other commercial use, which were landed in the State of New South Wales, must be from a licensed commercial fisher or a person acting on behalf of such a commercial fisher.
5. The person or company authorised by the Certificate of Registration does not engage commercial fishers as agents.
6. Applicants who apply to handle live fish must demonstrate that they have the necessary equipment and facilities to do so and maintain those fish in a humane condition prior to on sale.
7. The certificate holder must immediately report to NSW DPI any instances of eastern rock lobster tags becoming detached from any eastern rock lobsters in their possession.
8. The certificate holder must disable any used eastern rock lobster tags by the method of cutting the loop of the locking mechanism in half immediately after removing the tag from an eastern rock lobster or immediately once the tag has become detached from an eastern rock lobster.
9. These conditions may change or be altered by a delegated officer in writing to the registered fish receiver.
10. The certificate holder must display the certificate at a prominent location within public display at their registered premises.

This certificate is subject to cancellation, variation or amendment at any time by notice sent to the holder at the last known address, and if so cancelled, varied or amended must be delivered to a NSW DPI Fisheries Officer on demand.
